The undersigned understands and agrees to the following: 1) Applications shall be submitted BEFORE container placement. 2) The permittee shall comply with all permit provisions in Municipal Code 40-13 along with any conditions attached to this issued permit. 3) Application fee is non-refundable. 4) Unless specifically allowed, all containers and dumpsters occupying the street must be placed in a legal parking zone. 5) Temporary traffic control shall be provided and maintained by the applicant and shall comply with Part 6 of the Manual on Uniform Traffic Control Devices (MUTCD).

A permit is required anytime you place a portable storage container or dumpster within the City's Right of Way.

To apply for a permit:

- Return this completed application along with fees noted below via email to engineering@cityoflacrosse.org or mail to or drop off at City of La Crosse, Engineering Department, 400 La Crosse Street, La Crosse, WI 54601.
- **Average completion time for validation is 5 days.**

A permit costs:

- \$75 for a 14-day permit
- \$500 if no permit applied for

Insurance is required.

- Public liability of not less than \$200,000 for one person, \$500,000 for one accident and property damage insurance of \$100,000.
- The Certificate of Insurance **must** name the City of La Crosse as Additional Insured.
- Bond of \$3,000 by an approved insurance or security company to cover any damages that may occur to city property.

Follow these regulations:

- Prominently display the Name, Address and Phone Number of Applicant on each storage container or dumpster.
- Equip each storage container or dumpster with reflectorized tape or other reflector devices and flashers on both front and rear.
- Do not place any storage container or dumpster in a moving lane of traffic or interfere with public works construction.
- Place the storage container or dumpster on streets in legal parking zones only.
- Submit this Application before placing the storage container or dumpster.

Failure to obtain a permit before commencement of work will result in a permit fee of \$500.
